

los potenciales efectos del Hg en la biota acuática y en las poblaciones humanas Amazónicas. En este sentido hacen falta estudios en la definición de bioindicadores idóneos de contaminación de Hg, para el cuidado y prevención del ambiente y de las poblacio-

nes humanas Amazónicas que dependen de sus recursos hidrobiológicos. Un buen bioindicador, debe integrar la variabilidad estacional (regímenes de inundación periódica) y regional (diferentes medios) a la que está sometida la Amazonía.
